**RESOLUTION No. 74 of 2016**

**RESOLUTION APPROVING PRELIMINARY BUDGET OF TOWN OF AMENIA AND  
DIRECTING A PUBLIC HEARING THEREON**

The Town Board of the Town of Amenia (hereinafter "Town Board"), duly convened in regular session, and the meeting having been called to order by Supervisor Victoria Perotti, does hereby resolve as follows:

1. Pursuant to and in accordance with the provisions of Section 106 of the Town Law of the State of New York and other applicable provisions of law, the annexed detailed statement of estimated expenditures and revenues be and the same hereby is approved and adopted as the Preliminary Budget of the Town of Amenia for the fiscal year beginning January 1, 2017.
2. Such Preliminary Budget shall be filed forthwith in the Office of the Town Clerk of the Town of Amenia where it shall be available for public inspection.
3. The Town Board of the Town of Amenia shall meet at Town Hall on November 15, 2016 and then and there hold a public hearing upon such Preliminary Budget.
4. The Town Clerk of the Town of Amenia shall give notice of such public hearing by publishing notice thereof in the form annexed in the official paper of the Town, The Millerton News, at least five (5) days prior to November 15, 2016 and shall cause a copy of said notice to be posted in Town Hall not later than five (5) days prior to November 15, 2016.
5. This Resolution shall take effect immediately.
