Public Comment

Mark Doyle commented on the notice the town received from DEC regarding Kent Hollow Mine and inquired if the town will be seeking lead agency. He shared significance to the area and possible negative impacts of the project.

Andy Durbridge commented on three separate issues. He suggested inviting Congressman Faso to visit the community; the quality and functionality of the town's website and in regards to Kent Hollow Mine he thinks the town should seek lead agency.

Tonia Shoumatoff commented favorably in regards to Ian Hollback and his current projects and community support.

Walter Brett commented on the anti-Semitic signage

Michael Chamberlin commented on the proposed Kent Hollow application, supporting the previous comments of the Board seeking lead agency, Amenia land use and zoning

Town wide Renegades Bus Trip

Michelle Somogyi, Recreation member presented a bus trip open for all town residents and requested authorization to spend the funds for bus transportation. She announced upcoming recreation activities. V. Doyle motioned, seconded by D. Gutierrez to authorize expenditures of \$765 for proposed bus trip. Recreation Commission Member Term Length Discussion

Attorney Fitzpatrick referred to General Municipal Law section 243 that sets the rule for term limits. The current Recreation Commission has seven members each with a term to expire one on a given year. No additional action was taken.

Ridgecrest Special Permit and Conservation Easement

Attorney Don Cappillino and applicant Ian Hollback were present. Attorney Cappillino addressed the Board with a brief history of the project and inquired if they board wanted to see the land conservancy imposed. As the applicant now has acquired the surrounding properties is this a vision of the town the same. Adjacent properties are in the Transit-Oriented District and with there being a limited number of sites in this area to develop, prior this applicant beginning the process for a land conservancy he would like to confirm with the town. Supervisor Perotti thanked Attorney Cappillino for the presentation. NO action was taken as the board will need to discuss this matter in executive session.

V. Perotti read aloud a resolution amending the road lengths of Glenn Road and May Lane in the town V. Perotti motioned, seconded by D. Gutierrez to accept Resolution #9 of 2017 to Authorize to Amend and Accept Revised Lengths of Maintained Roads Within the Town of Amenia

Lead Agency Coordination Request has been received from the NYS DEC for Kent Hollow Mine-Proposed Sand and Gravel Mine; letter dated February 10, 2017.

Attorney Everett responded to the board that their next action is to determine if they want to seek lead agency, a benefit being the town will identify environmental issues and coordinate the review, higher consideration for town zoning; a disadvantage being DEC has the mining experts already in place and their focus is the mining portion project.

Members of the audience had the opportunity to be heard.

D. Gutierrez motioned, seconded by V. Perotti the town reply to the DEC and request lead agency. Discussion: DeLango discussed the last time a lead agency request was presented; the town opted not to because of the costs and other matters on the board's agenda.
