The Town of Amenia, Town Board began their meeting at 7:00pm on Thursday, March 18, 2021 at 4988 Route 22, Amenia New York. Supervisor Perotti moved to open the meeting. Roll Call was taken by the Clerk with the following members present via video conferencing:

Lavelle Road Pump House Repair Cost Estimate - John Andrews Town Engineer

Mr. Andrews presented cost estimate for the design, permitting and construction of a replacement pump house for the Amenia Water District, Lavelle Road Pump House in the estimated amount of \$336,000. Mr. Andrew recommends that they consider alternatives at this cost.

Deidra Houston, County Legislature

Provided an update on the County – the County is due to received 57.5 million dollars for the American Rescue Plan with the first part of the funds to be received in the next 60 days. First the funding's are set to help with the cost of Covid expenses and second, the funding of the monies is help towns with infrastructure which in include water, sewer and broadband. She is happy to partner with Ameria as plans develop. She shared the 2-1-1 hotline for updating eviction information and resources. She shared Covid vaccines sites locations.

Supervisor's Report, Victoria Perotti, Town Supervisor

Supervisor Perotti reported: 1. Lavelle Road Pump House and Generator Upgrade –The Town Board will be reviewing the town engineer report and looking into how to fund the repairs.

- 2. Altice-franchise agreement negotiations are still in progress.
- 3. NYS Employer Mandatory Emergency Plan-The Town of Amenia NYS Employer Mandatory Emergency Plan has been completed before the April 1 deadline and is ready for approval.
- 4. American Rescue Package- Supervisor Perotti attended the Association of Towns conference call with Senator Schumer on March 11. The Town of Amenia is projected to receive \$480,000. This amount can only be used for Covid-19 costs, grants to eligible employers with essential workers, to cover revenue losses, or to make necessary investments in water, sewer, and broad band. The funds for towns with populations under 50,000 using the 2019 Census to identify populations eligible for assistance will be sent to the states which can hold the funds for 30-120 days but are not allowed to add additional charges or requirements.
- 5. Town of Amenia Covid-19 (Coronavirus) —The Amenia Town Hall will remain closed but will be available to departments by appointment. Department extensions are posted on the front door. There is also a doorbell to the left of the main door. Each department is also available by phone, mail, email and secure lockbox on the building to the left of the front door. Town Board and

other meetings will be held by Zoom. Public Comments for Town Board meetings can be made by email or mail sent to the Town Clerk who will read them at the meeting. Public Hearing meetings will be set up by video and telephonic conferencing advertised with information about how to attend. Court Administration has ordered that court in person appearances can resume. Vaccine information can be found on the front door, Channel 22, and on the website. Sign up on www.DutchessNY.gov/VaccineInfoForm or call the Dutchess County Coronavirus Information Line at (845) 486-3555. Select Option 1 to hear the weekly vaccine allocation updates THEN select Option 2 to be connected to the Office of the Aging and added to the notification list. There is also vaccine being distributed by pharmacies and large medical groups. The Town Hall will be opened to modified Recreation activities with all Covid-19 protocols in place. In addition the Recreation Commission and other committees will be able to meet in-person as long as Covid-19 protocols are followed. Please continue to wear face coverings and be mindful of social distancing. Also remember to not touch your face, wash your hands often, and use hand sanitizer. Be well and stay safe.

Town Clerk's Report, Dawn Marie Klingner, Town Clerk

Clerk Klingner presented the total taxes collected as of this date \$5,523,130.21 with penalties totaling \$2,827.34. Circulated prior to the meeting the annual audit performed by RBT for the Tax Collector and Justice Court. Clerk circulated another parking complaint received from a resident. Read into the record, that she and highway superintendent opened the bids on March 11th – Bids were received from TJR Excavating Contractors (\$49,750); LandVscape Inc (\$37,925); Land Works Excavating (\$31,236); Woodland Manor LLC (\$45, 034.73); Champion Maintenance Contractors (\$16,966.75); Linda Holding Corp dba Maggio & Sons (\$59,750) and Con-Tech Construction Technology (\$30,000).

Clerk received one volunteer application from Stacy Mantel who is interested on serving on a Broadband Committee. Supervisor Perotti has already had the opportunity to speak with her and explained that there needs to be at least three people on a committee before the committee can be formed.

Clerk acknowledged receipt of the following reports that were sent to her and Board- the usage and activity report from SEBI's monthly report of February; February Balance Sheet and Operating Statement as sent to us by the Bookkeeper.

Presented the Vouchers in the total amount of \$316,609.11 for approval; and shared the upcoming community events.
