RESOLUTION No. 54 of 2021

**RE: ADOPTION OF PRELIMINARY BUDGET FOR FISCAL YEAR 2022
AND ESTABLISHING A PUBLIC HEARING DATE**

WHEREAS, the Town Supervisor has filed the 2022 Tentative Budget for the Town of Amenia pursuant to Section 106 of the Town Law; and

WHEREAS, the Town Clerk delivered the Tentative Budget to the Town Board in accordance with Town Law Section 106; and

WHEREAS, Town Law Section 108, requires the Town to hold a Public Hearing on a Preliminary Budget on or before the Thursday immediately following the General Election in November; and

WHEREAS, Town Law Section 109 requires that the Town Board to adopt a Final Budget on or before November 20, 2021; and

WHEREAS, the Town Board has reviewed the Tentative Budget and has made changes thereto deemed reasonable and appropriate and intends to adopt the Preliminary Budget herewith.

NOW THEREFORE BE IT RESOLVED, as follows:

1. The recitations set forth above are incorporated in this Resolution as if fully set forth and adopted herein.
2. Pursuant to and in accordance with the provisions of Section 106 of the Town Law, and other applicable provisions of law, the annexed Tentative Budget is hereby approved and adopted as the Preliminary Budget for the Town of Amenia for the fiscal year beginning January 1, 2022.
3. The Preliminary Budget adopted herein shall be filed in the Office of the Town Clerk in the Town of Amenia where it shall be available for public inspection Monday through Thursday between 9:00am and 3:00pm. It can also be downloaded from the Town's website at www.ameniany.gov or available by email upon request to the Town Clerk, Dawn Marie Klingner, at dmklingner@ameniany.gov.

4. That the Town Board of the Town of Amenia shall meet at Town Hall located at 4988 Route 22, Amenia, New York on Thursday, November 4, 2021, at 7:00 p.m. for a Regular Town Board Meeting for the purposes of conducting a Public Hearing on the Preliminary Budget.
5. That the Town Clerk of the Town of Amenia is hereby directed and authorized to publish the Notice of the Public Hearing in the format annexed hereto in the official newspaper of the Town of Amenia at least five (5) days prior to the scheduled Public Hearing and the Town Clerk shall cause a copy of said notice to be posted on the official sign board of the Town no later than five (5) days before the scheduled public hearing.
