The Town of Amenia, Town Board began their meeting at 7:00pm on Thursday, August 19, 2021 at 4988 Route 22, Amenia New York. Supervisor Perotti moved to open the meeting, there was a Salute to the Flag and the emergency exits were pointed out. Roll Call was taken by the Clerk with the following members present:

Leo Blackman- thanked Supervisor Perotti for finding funds for hiring the wastewater engineer

Supervisor's Report, Victoria Perotti, Town Supervisor

Supervisor Perotti presented the following:

Water District Upgrade — the Water Operator and the Town Board are researching places for new wells and will also be working on a capital plan and asset inventory of the Water District which is required as part of the requirements for the American Rescue Funds to be used for infrastructure improvements.

Altice-negotiations are in progress

American Rescue Package- Supervisor Perotti attended an informational webinar by the Government Officers Finance Association and also contacted the Association of Towns for a contact to the EPA Region 6 for New York. After contacting the EPA contact by email I was given additional information about the requirements for using the American Rescue Funds for water infrastructure capital projects in addition to contact information for the Treasury department which administers the program. Eligibility for a project is based on what would be eligible under the Clean Water State Revolving Fund and the Drinking Water State Revolving Fund grants.

Highway Garage-the RFP bids were due today and have been received by the Town Clerk. The Town Board and the Town Attorney will have to review them before the winning bid is announced.

CDBG sidewalk grant – the DOT Work Permit for the Amenia Post Office area repairs has been received after sending a required \$5000 retainer to the DOT which will be returned to the Town of Amenia after the project is finished. There will be a meeting with the contractor and engineer at the Amenia Post Office at 10:00 am tomorrow to go over the project.

2022 Budget- 2022 budget worksheets have been distributed to all departments and other entities. The Recreation Commission worked on them at their meeting on Tuesday of this week. They are required to be completed by September 8^{th} .

New Website- the Town of Amenia new website through a Shared Services contract with Dutchess County OCIS will go live on September 1st.

Town of Amenia Covid-19 – The Amenia Town Hall is open for business as usual Monday through Thursday at regular business hours. New CDC guidance is masks are recommended in substantial or high

transmission areas even if you are vaccinated. Signing the Visitor Log with contact information is required.

Discussions

American Rescue Plan

Supervisor shared the steps to be completed for the use of the American Rescue Plan Funds. The Town will need to put together a Capital Project Plan, addressing the infrastructure issues in the Water District, and an Asset Inventory of the Water District. A long-range Water District Plan will also be something that needs to be completed. Discussed using the current water operator's firm who prepared the 2018 report that prioritized a plan of how he would spend money if he had the funds. Discussed the option of hiring an outside group that would take a comprehensive look at the district with aging infrastructure, as there were several firms with water district experience who submitted RFPs for this project and the board liked Erin from Tighe and Bond. Discussed working with the Town's engineer John Andrews who had reviewed those submissions. It was decided to invite John Andrews to the next meeting and discuss further.

Gutierrez shared other alternate use ideas for using the monies for other special districts -ie generators for the fire districts and water district; creating an ambulance district; and using for Broadband, cyber security programs or digital literacy training

Gutierrez clarified comments that Leo Blackman made regarding the real estate department of Hudson River Housing is not the position of the Town of Amenia.

Somogyi recognized 100 years of Women's Right to Vote by giving all the women a yellow rose. shared the upcoming senior events. She shared there are grants available for signage. Building inspector advised the board that they need to update the current law to allow for light admitting diodes. The attorney will follow up on this item. Somogyi announced upcoming community events.
