RESOLUTION No. 81 of 2023

RE: RESOLUTION AWARDING CONTRACT TO REPLACE WATER METER WITHIN THE TOWN OF AMENIA WATER DISTRICT NO. 1

WHEREAS, Town of Amenia Water District No. 1 has a water meter which requires the services of a plumber to replace, due to its location; and

WHEREAS, the Town of Amenia Water Operator, SEBI Environmental Services, Inc. ("SEBI"), requested written quotes from T. Webber Plumbing, Heating, Air & Electric; Lambert Plumbing & Heating; and Elliott Plumbing, Heating & Air Conditioning, Inc. and received the following:

WHEREAS, Marco D'Antonio of SEBI has reviewed the quotes provided and has recommended Elliott Plumbing, Heating & Air Conditioning, Inc. as they are the lowest responsible quote received and have excellent results from prior work performed; and

WHEREAS, the Town Board of the Town of Amenia, pursuant to the recommendation of the Town Water Operator, desires to award a contract to Elliott Plumbing, Heating & Air Conditioning, Inc. in the amount of \$275.00 in accordance with the proposal annexed hereto; and

WHEREAS, this is a Type II action under the State Environmental Quality Review Act ("SEQRA") and therefore not subject to review under SEQRA.

NOW, THERFORE, BE IT RESOLVED, as follows:

- 1. The recitations above set forth are incorporated in this Resolution as if fully set forth and adopted herein.
- 2. The Town Board of the Town of Amenia hereby authorizes the contract to replace a water meter within the Town of Amenia Water District No. 1 to Elliott Plumbing, Heating & Air Conditioning, Inc. in the amount of \$275.00.
- 3. The Town Board hereby authorizes the Town Supervisor to execute a contract in accordance with the proposal annexed hereto.
 - 4. The Town Board of the Town of Amenia hereby authorizes the payment for said services to be paid from Transmission Distribution Budget Line No. 83404.0.0.0.
 - 5. The Town Supervisor is hereby directed to provide a copy of the contract signed by all parties to the Town Clerk, who shall maintain the same in her files.
