### **Resolution No. 83 of 2023**

#### **RE: AWARDING BID FOR THE EXTENSION OF ROUTE 44 SIDEWALK PROJECT**

**WHEREAS**, the Town Board of the Town of Amenia previously authorized LaBella Associates (LaBella) to prepare bids and specifications for the Extension of Route 44 Sidewalk Project in the Town of Amenia; and

**WHEREAS**, two (2) bids were received on June 7, 2023; and

**WHEREAS**, by letter dated June 13, 2023, Labella recommended that the bids be rejected due to missing information and other irregularities; and

**WHEREAS**, the Town Board, by Resolution No. 73 of 2023, rejected all bids and authorized LaBella to solicit new bids; and

**WHEREAS**, bids were duly advertised and solicited for the work to be conducted and three (3) bids were received, opened and read aloud by the Town Clerk on July 12, 2023; and

**WHEREAS**, the following bids were received:

Con-Tech Construction Technology, Inc.	\$208,500.00
B&K Excavations, Inc.	\$257,450.00

**WHEREAS**, by letter dated July 14, 2023, LaBella advised that the lowest responsible bidder was Raja Contractors, Inc. and recommends that the Town Board award the contract to Raja Contractors, Inc. in the amount of \$197,050, all as set forth in the aforementioned recommendation letter, a copy of which is annexed hereto and made a part hereof.

**NOW, THEREFORE, BE IT RESOLVED,** as follows:

1. The recitations set forth above are incorporated in this Resolution as if fully set forth and adopted herein.
2. The Town of Amenia hereby awards the contract for the Extension of Route 44 Sidewalk Project to Raja Contractors, Inc. in the amount of \$197,050.
3. In accordance with the authorized bid specifications, the Town Board hereby authorizes the Supervisor to execute the contract documents as prepared by the Engineers to the Town, including the Notice of Award and Notice to Proceed, and forward a copy to Raja Contractors, Inc. after the Attorney to the Town has confirmed that Raja Contractors, Inc. has duly executed the contract documents, has supplied the necessary Performance Bond, Labor and Materials Payment Bond and provided insurance certificates as required by the bid specifications.
4. Funding for this project shall be paid from the Engineers Budget Line No. 14404.01.
