RE: ADOPTING FEE SCHEDULE FOR THE BUILDING DEPARTMENT FOR CALENDAR YEAR 2024

WHEREAS, the Town Board of the Town of Amenia is seeking to revise the Building Department fee schedule for the submission of applications, the issuance of building permits, amended building permits, renewed building permits, certificates of occupancy, operating permits, fire safety and property maintenance inspections and other actions of the Code Enforcement Officer described in and or contemplated in Chapter 63 of the Town Code; and

WHEREAS, the Town Code Enforcement Officer has recommended that the Town Board consider increasing certain fees, which have not been increased in many years; and

WHEREAS, pursuant to Town Code Sections 63-16 the fees charged and collected for the submission of applications, the issuance of building permits, amended building permits, renewed building permits, certificates of occupancy, operating permits, fire safety and property maintenance inspections and other actions of the Code Enforcement Officer described in and or contemplated in Chapter 63 of the Town Code shall be established and amended by Town Board Resolution.

NOW THEREFORE, BE IT RESOLVED, as follows:

1. The recitations set forth above are incorporated in this Resolution as if fully set forth and adopted herein.

2. The Town Board of the Town of Amenia hereby adopts the annexed Building Department fee schedule effective January 1, 2024.
