TOWN WIDE BURN BAN

A State of Emergency is hereby declared in Town of Amenia effective at

This State of Emergency has been declared due to the extreme dry conditions and lack of rain.

The National Weather Services has indicated RED FLAG WARNING, signifying critical fire weather conditions with low humidity, strong winds and high potential for rapid fire spread. Effective immediately, the Town of Amenia has declared a Town-wide BURN BAN. This includes all brush, burning barrels and camp fires etc.
