

PAYMENT OF TAXES

PAYMENT OF TAXES CAN BE MADE BY MAIL WITH THE POST OFFICE POSTMARK BEING USED AS THE DATE OF RECEIPT OR TAXES CAN BE PAID TO THE TAX COLLECTORS IN ACCORDANCE WITH THE SCHEDULE OF LOCATIONS AND DATES TO RECEIVE TAXES AS SHOWN ON THE FRONT OF THIS TAX BILL AND LISTED IN YOUR LOCAL PAPER

PENALTIES FOR LATE PAYMENT

TAXES MAY BE PAID ON OR BEFORE THE 30TH DAY AFTER THE FIRST PUBLISHED NOTICE IN YOUR LOCAL PAPER WITHOUT INTEREST. ON ALL SUCH TAXES REMAINING UNPAID AFTER THE ONE MONTH PENALTY FREE PERIOD HAS ENDED THERE SHALL BE ADDED 1% FOR EACH MONTH AND FRACTION THEREOF THEREAFTER UNTIL THE RETURN OF UNPAID TAXES IS MADE BY THE COLLECTOR TO THE COUNTY TREASURER PURSUANT TO LAW.

ALL SCHOOL DISTRICTS EXCEPT FOR CITY SCHOOLS

AT THE END OF COLLECTION, PAYMENT CAN ONLY BE MADE TO THE DUTCHESS COUNTY COMMISSIONER OF FINANCE, 22 MARKET STREET, FINANCE DEPARTMENT 4TH FLOOR, POUGHKEEPSIE, NY 12601. PLEASE CALL THE COMMISSIONER OF FINANCE'S OFFICE AT (845)486-2026 FOR THE CORRECT AMOUNT DUE. UPON THE RETURN OF UNPAID TAXES TO THE TREASURER, INTEREST CONTINUES TO INCUR UNTIL THE DATE THAT THE COUNTY LEGISLATURE AUTHORIZES THE RELEVY OF UNPAID SCHOOL TAXES ONTO THE NEXT COUNTY TOWN BILL.

ALL SCHOOLS WILL BE RELEVIED, EXCEPT FOR THE CITY OF BEACON, WITH THE ADDITION OF 7% PENALTY AS PRESCRIBED IN STATE LAW.

GRIEVANCE PROCESS

PLEASE CONTACT THE LOCAL ASSESSOR AND ASK FOR THE BOOKLET ENTITLED 'CONTESTING YOUR ASSESSMENT IN NEW YORK STATE' ALSO AVAILABLE ONLINE AT WWW.TAX.NY.GOV/PDF/PUBLICATIONS/ORPTS/GRIEVANCEBOOKLET.PDF. PLEASE NOTE THAT THE PERIOD FOR FILING COMPLAINTS ON THIS ASSESSMENT HAS PASSED.

INCORRECT ADDRESS / OWNER

IF THE ADDRESS ON THE FRONT OF THE BILL IS INCORRECT, PLEASE NOTIFY THE ASSESSOR AND TAX COLLECTOR OF THE CORRECT ADDRESS. IF YOU NO LONGER OWN THIS PROPERTY, IT IS EXTREMELY IMPORTANT THAT YOU FORWARD THIS TAX BILL TO THE NEW OWNER. IF YOU DO NOT KNOW THE NAME AND ADDRESS OF THE NEW OWNER, PLEASE RETURN THIS BILL TO THE TAX COLLECTOR, INDICATING THAT YOU ARE NO LONGER THE OWNER.

THIRD PARTY NOTIFICATION

IF YOU ARE EITHER 65 YEARS OF AGE OR OLDER OR DISABLED AND YOU OWN AND OCCUPY A 1, 2, OR 3 FAMILY RESIDENCE, YOU MAY DESIGNATE A CONSENTING ADULT THIRD PARTY TO RECEIVE DUPLICATE COPIES OF YOUR TAX BILLS AND NOTICES OF UNPAID TAXES UNTIL FURTHER NOTICE. APPLICATIONS MAY BE OBTAINED IN PERSON FROM YOUR TAX COLLECTING OFFICER OR COUNTY REAL PROPERTY TAX SERVICES, OR BY MAIL IF YOU INCLUDE WITH YOUR REQUEST A SELF ADDRESSED STAMPED ENVELOPE. APPLICATIONS FOR THIRD PARTY NOTIFICATIONS MUST BE FILED WITH THE TAX COLLECTING OFFICER NO LATER THAN JULY 15.

POSSIBLE TAX EXEMPTIONS

IF YOU ARE A SENIOR CITIZEN, A PERSON WITH A PHYSICAL DISABILITY AND/OR A VETERAN, YOU MAY BE ENTITLED TO A PARTIAL EXEMPTION FROM PROPERTY TAXES. ELIGIBLE HOMEOWNERS HAVE UNTIL MARCH 1ST TO APPLY FOR SUCH EXEMPTIONS. FOR FURTHER INFORMATION PLEASE CALL OR WRITE TO THE ASSESSOR'S OFFICE.
