# RE: AUTHORIZING THE PURCHASE AND INSTALLATION OF PLAYGROUND EQUIPMENT FOR BEEKMAN PARK

WHEREAS, the Town of Amenia desires to enhance Beekman Park by purchasing and installing new playground equipment; and

WHEREAS, pursuant to General Municipal Law § 103(16), municipalities are authorized to purchase equipment and contract for services related to installation thereof through the use of a contract let by the United States of America or any agency thereof, any state or any other county of political subdivision or district therein, if such contract was let in a manner that constitutes competitive bidding consistent with state law and made available for use by other governmental entities; and

WHEREAS, the Town of Amenia is a member of the Sourcewell Cooperative Purchasing Program ("Sourcewell"), Supplier # 010521-LTS, Agency # 96577, and is in compliance with General Municipal Law § 103(16); and

WHEREAS, the Town of Amenia has been provided a proposal from Great Lakes Recreation – DBA NE REC Co. through Sourcewell for the purchase and installation of playground equipment in the amount of \$131,020.00, a copy of which is annexed hereto; and

WHEREAS, the Town Board of the Town of Amenia wishes to award the contract to Great Lakes Recreation – DBA NE REC Co. for the purchase and installation of playground equipment for Beekman Park in the amount of \$131,020.00, and in accordance with the annexed proposal.

### **NOW, THEREFORE, BE IT RESOLVED**, as follows:

- 1. The recitations set forth above are incorporated in this Resolution as if fully set forth and adopted herein.
- 2. The Town Board of the Town of Amenia hereby awards the contract for the purchase and installation of playground equipment for Beekman Park to Great Lakes Recreation DBA NE REC Co. in the amount of \$131,020.00, and in accordance with the annexed proposal.

- 3. The Town Board of the Town of Amenia hereby authorizes and directs the payment for such services from the Park and Rec Budget Line No. 205.01 in the amount of \$128,268.63 with the balance to be paid from the Special Items CE Budget Line No. 1900.4 in the amount of \$2,751.37.
